

The consent of the website user to the processing of personal data

1. I, hereinafter referred to as the "Subject of Personal Data", in accordance with the Federal Law of 27.07.2006 No. 152-FZ "On personal data" (as amended and supplemented), acting freely, by my will and in my interest give my consent to Magnezit Group LLC, hereinafter the "Operator", to the processing of my personal data specified at the registration for the international online conference of Magnezit Group LLC on the topic "Digitalization of industrial thermal processes and units", hereinafter — the Conference, by filling out a web form at <https://interaction.magnezit.ru/conference/> and/or <https://interaction.magnezit.ru/en/conference/>, hereinafter referred to as the "Website", sent (completed) using the Site.
2. Consent to the processing of personal data is given by ticking the "checkmark" of the Subject of personal data in the appropriate web form placed on the operator's Website for registration at the Conference.
3. Personal data understood to be any information relating to me as a Subject of personal data, including my name, surname, patronymic, company/organisation, position/status, choice to participate in the section, e-mail, other information that I consider necessary to additionally pass on to the Operator at my discretion. Personal data processing is understood to be collection, systematization, accumulation, specification, updating, modification, use, distribution, transfer, including cross-border one, depersonalization, blocking, destruction, storage and any other actions (operations) with personal data.
4. Processing of personal data of the Subject of personal data is carried out exclusively for the purpose of registration of the Subject of personal data for the Conference in the Operator's database with subsequent sending of postal messages for participation in the Conference to the Subject of personal data, in particular, information mailings and notifications about the forthcoming event and an invitation containing data for entering the Zoom platform for participation in the Conference, execution of the Participant Certificate after the Conference, determination of the number of participants in each of the sections and moderation of communication for uninterrupted operation of each section of the Conference, collection and processing of anonymous data on where the participants of the Conference (Subjects of Personal Data) learned about the Conference for further operation of the Operator.
5. The date of issue of the consent for processing of personal data of the Subjects of personal data is the date of sending the registration web form from the Website.
6. Processing of personal data of the Subject of personal data may be performed with the help of automation means and/or without the use of automation means in accordance with the current legislation of the Russian Federation and internal regulations of the Operator.
7. The Operator takes the necessary legal, organisational and technical measures or ensures their adoption to protect personal data from unlawful or accidental access, destruction, alteration, blocking, copying, provision, distribution of personal data, as well as from other unlawful actions in relation to personal data, and undertakes the obligation to preserve the confidentiality of personal

data of the Subject of personal data. The Operator has the right to involve subcontractors for processing of personal data of the Subjects of personal data, and also has the right to transfer personal data for processing to its affiliates, thus ensuring that such subcontractors and affiliates assume the corresponding obligations in respect of confidentiality of personal data.

- this consent to the processing of my personal data, specified in the registration for the Operator's Conference, sent (filled in) using the Website, is valid for three (3) years from the date of registration on the Operator's Website for participation in the Conference;

- provision of personal data of third parties without their consent entails liability in accordance with the current legislation of the Russian Federation.
